  - o How do we align ourselves and support the county and municipalities?
  - Desire for county buy-in wish to share vision for a unified step forward, and One Marshall County can be a tool to accomplish that.
- Fundraising Strategy
  - What is the best way to approach organizations and get buy-in for One Marshall County?
  - Plymouth re-expressed buy-in, but want to make sure they're seeing ROI. Getting an update from Jeff at council meetings has been a big help.
  - Recommendation to consistently send out minutes to municipalities Matthew
    Celmer mentioned that he can send the minutes.

- We may need to re-adjust our financial ask based on a new budget, as of now our expenses are less without an Executive DIrector and other staff.
  - Need for *project* related budgets
    - Website, setting up quickbooks, etc.
    - This is good because redevelopment commissions can fund projects!
